
# Intimate care policy (EYFS)

### Intimate Care and Toileting Policy & Procedure for Little Acorns & Acorns (EYFS) (for Governors February 2022)

At Leconfield Primary School we are committed to safeguarding and promoting the welfare of children and young people. We are committed to ensuring that all staff responsible for intimate care of children and young people will undertake their duties in a professional manner at all times. We are committed to ensuring that children are treated with sensitivity and respect.

#### **Definition of intimate care**

Any care which involves washing, touching or carrying out an invasive procedure that most children and young people carry out for themselves, but which some are too young to or are unable to do.

Intimate care tasks are associated with bodily functions, body products and personal hygiene that demands direct or indirect contact with, or contact with intimate personal areas.

Examples include support with dressing and undressing (underwear), changing and nappies and pull ups, helping someone use the toilet or washing intimate parts of the body, cleaning a pupil who has soiled him/herself or vomited. It is also associated with other accidents that may require a child to remove their clothes. These include changes required as a result of water play, messy play, sickness and weather. Very young or disabled pupils may be unable to meet their own care needs for a variety of reasons and will require regular support.

#### **Practicalities**

It is generally expected that most children will be toilet trained and out of nappies before they begin at school or nursery. However, we recognise that children will join Leconfield Primary school, having reached differing levels of independence and development in toileting and self-care. Therefore, it is inevitable that from time to time some children will have accidents and need to be attended to. In addition to this, an increasing number of children and young people with disabilities and medical conditions are being included in mainstream settings. A significant number of these pupils require adult assistance for their personal and intimate care needs. In order to help the children to become aware of their bodily needs and respond to them in time, those who wish to go to the toilet are always allowed to go. Although they are encouraged as they progress through the school to use the toilet during break times. Children in the EYFS have access to the toilet whenever they need to and are encouraged to be as independent as is age and developmentally appropriate. They are reminded at regular times to go to the toilet and are also encouraged to wash their hands after the toilet.

#### **Role of Leconfield Primary School staff**

Foundation Stage staff have access to the toilet area and a hand basin with access to warm water.

There is also a stock of baby wipes, plastic bags and disposable protective gloves for staff to use. If a child soils him/herself during school time, one member of the EYFS staff (teacher, teaching assistant,) will help the child:

- · Remove their soiled clothes
- Clean skin (this usually includes bottom, genitalia, legs, feet)
- Dress in the child's own clothes or those provided by the school
- Wrap soiled clothes in plastic bags and given to parents to take home.

At all times the member of staff pays attention to the level of distress and comfort of the child. If the child is ill the member of staff will telephone the parent/carer. In the event a child is reluctant and finally refuses, the parent/carer will be contacted immediately. Our intention is that the child will never be left in soiled clothing, but as soon as a member of staff is aware of the situation, she/he will clean the child. The member of staff responsible will check the child regularly and ensure that he/she is clean before leaving to go home.

It is intended that the child will not experience any negative disciplining, but only positive encouragement and praise for his/her endeavours to master this necessary skill. It is always our intention to avoid drawing attention to such events and positively to encourage the child in his/her efforts to gain these skills.

#### Guidance for intimate care needs over and above accidents.

The management of all children with intimate care needs will be carefully planned. Where specialist equipment and facilities above that currently available in the school are required, every effort will be made to provide appropriate facilities in a timely fashion, following assessment by a Physiotherapist and/or Occupational Therapist. There is careful communication with any pupil who requires intimate care in line with their preferred means of communication to discuss needs and preferences. Staff will be supported to adapt their practice in relation to the needs of individual children. Pupils will be supported to achieve the highest level of independence possible, according to their individual condition and abilities.

Individual care plans will be drawn up for any pupil requiring regular intimate care. Careful consideration will be given to individual situations to determine how many adults should be present during intimate care procedures. Where possible, one pupil will be cared for by one adult unless there is a sound reason for having more adults present. In such a case, the reasons will be documented. Intimate care arrangements will be discussed with parents/carers and recorded on the care plan.

The needs and wishes of children and parents will be taken into account wherever possible, within the constraints of staffing and equal opportunities legislation.

#### **Child Protection**

Child Protection and Multi-Agency Child Protection procedures will be adhered to at all times. All members of staff carrying out intimate care procedures have enhanced DBS. Students should only do so under the supervision of a trained member of staff. It is not appropriate for volunteers to carry out intimate care procedures. If a child makes an allegation about a member of staff, this will be investigated in accordance with agreed procedures.

#### **Disabilities**

The Governing Body recognises its duties and responsibilities in relation to the Equality Act 2010 which requires that any child with an impairment that affects his/her ability to carry out normal day-to-day activities must not be discriminated against.

#### Role of parents/carers

Parents/carers should give permission for intimate care as children enter Early Years Foundation Stage (EYFS). The permission slips are kept on record. All staff are informed of those children where no permission is given. Where a child has continuing incontinence problems (including children beyond EYFS), parents are expected to provide a complete set of spare clothes and babywipes.

## Leconfield Primary School Foundation Stage Intimate Care Procedures

In the event of a child accidentally wetting or soiling themselves or needing to have a nappy/pull up changed the following procedures are to be followed.

- Practitioners should not undertake any aspect of intimate care that has not been agreed between the setting, parents and child (if appropriate). In the event of consent to intimate care not being granted the child's parent / carer or emergency contact must be contacted so that they can make arrangements to change their child.
- If a parent / carer or emergency contact cannot be contacted the EYFS staff will clean and change the child to avoid the child becoming distressed and being in discomfort. Efforts to contact the parent / carer and emergency contact will be recorded.
- Changing will take place in the toilet area. There is no legal requirement that two
  members of staff will be involved in the provision of intimate care but another
  member of staff must be notified.
- Staff should wear a fresh disposable apron and gloves while changing a child.
- Soiled nappies/pull ups securely wrapped and disposed of appropriately.
- Changing area/ toilet to be left clean
- Hot water and soap available to wash hands as soon as changing is done and paper towels to be available to dry hands.
- If it is necessary to use a changing mat it will be placed inside a toilet cubicle to provide the child with privacy.
- Wet or soiled clothing is placed into a plastic bag to be returned to the parent / carer.
- The child is clothed in either clothing provided from home or in those provided by school.
- A record of provision of intimate care will be kept in a record book so that the individual administering the care can easily be identified.
- If during the intimate care of a child you accidentally hurt them, or the child misunderstands or misinterprets something, reassure the child, ensure their safety and report the incident immediately to Head / SLT
- Report and record any unusual emotional or behavioural response by the child. A
  written record of concerns must be made and kept in the child's personal file.
- The child's parent / carer is informed of the incident on collection in a discreet manner.

#### **Dear Parents & Carers**

#### Permission for Intimate Care

If a child wets or soils themselves whilst they are in school, it is important that measures are taken to have them changed and if necessary cleaned as quickly as possible. Our staff are experienced at carrying out this task if you wish them to do so or, if preferred, the school can contact you or your emergency contact who will be asked to attend without delay.
